Each participant may send maximum of 4 photographs to each section. The organizer can use the exhibited works for reproduction in the catalogue and for promotion without paying any author's fee.

You acknowledge and accept that entering this exhibition means that the status and results of your entry may be made public.

- B) WORLD IN FOCUS** (color/monochrome digital)
- C) PORTRAIT** (color/monochrome digital)
- D) WOMAN MAN CHILD** (color/monochrome digital)
- E) OPEN COLOR** (color digital)
- F) OPEN MONOCHROME** (monochrome digital)

- Each photo can be presented in only one section.

Pictures created by artificial intelligence are not allowed in salons run under FIAP patronage. It is reminded that all parts of the image have to be photographed by the author who is holding the copyright of all works submitted. **Offenders will be sanctioned for life!**

PHOTOGRAPHS

AUTHORS MUST FILL OUT ENTRY FORM AND SUBMIT PHOTOS ONLINE

- Photos must be in JPG file format, Max. image width (horizontal) is 1920 pix. Max. image height (vertical) is 1080 pix. in 300 dpi. compression 7-12, max 2Mb.

FILE NAMING

No requirements for file names, file name should be as you would want it to appear in the catalogue (same as title name). Our program will later add the necessary data. Words such as “Untitled” and

“No Title” are not acceptable as part or allof an image’s title, nor are camera capture filenames or titles consisting of only numbers. Only English letters (a-z) are allowed.
