

CONDITIONS OF ENTRY

The salon is open to amateur and professional photographers from all over the world. Entrants must be authors of the works they submit. Each participant may send maximum of 4 photographs to each section. The organizer can use the exhibited works for reproduction in the catalogue and for promotion without paying any author's fee.

DATA PROTECTION

By entering this exhibition, you are explicitly consenting to the personal details you have supplied, including email addresses, being held, processed and used by the exhibition organizers for purposes associated with this exhibition. You also explicitly consent to such information being sent to organizations which have accorded official recognition, patronage or accreditation to this exhibition. You acknowledge and accept that entering this exhibition means that the status and results of your entry may be made public.

Your email address and contact information will not be made public.

SECTIONS

- There are six sections, all digital:

- A) PHOTO TRAVEL** (color/monochrome digital)
- B) PHOTOJOURNALISM** (color/monochrome digital)
- C) PORTRAIT** (color/monochrome digital)
- D) WOMAN**(color/monochrome digital)
- E) OPEN COLOR** (color digital)
- F) OPEN MONOCHROME** (monochrome digital)

- Each photo can be presented in only one section.

PHOTOGRAPHS

AUTHORS MUST FILL OUT ENTRY FORM AND SUBMIT PHOTOS ONLINE

- Photos must be in JPG file format, Max. image width (horizontal) is 1920 pix. Max. image height (vertical) is 1080 pix. in 300 dpi. compression 7-12, max 2Mb.

FILE NAMING

No requirements for file names, file name should be as you would want it to appear in the catalogue (same as title name). Our program will later add the necessary data. Words such as "Untitled" and "No Title" are not acceptable as part or all of an image's title, nor are camera capture filenames or titles consisting of only numbers. Only English letters (a-z) are allowed.

ENTRY FEE

20Eur. for any **1** or **2** or **3** sections

25Eur. for any **4** or **5** or **all 6** sections

- The works of the authors who did not pay the fee would not be taken into consideration.
